## REGISTRATION/REFERRAL AGREEMENT

This agreement drawn on \_\_\_\_\_ 2021 between *AutoPersonnel<sup>SM</sup>, Inc* at 217 Baywood , Nicholasville, KY 40356) **Phone: (859-552-6016)** (AutoPersonnel) and \_\_\_\_\_ at \_\_\_\_\_ (Client) is a revocable agreement for the purpose of automotive personnel placement by AutoPersonnel for the Client.

Client will receive applications/resumes of potential employees who are contacts of AutoPersonnel. Client will not knowingly circumvent the work of AutoPersonnel with attempts to hire any referral around AutoPersonnel in order to avoid any agreed upon placement charges. Client agrees to notify AutoPersonnel<sup>SM</sup> of the first day of employment or rejection decision of all referrals.

Client is entitled to accept or reject any referred person for any reason. This agreement may be cancelled by either Party with 60 days notice.

**DEFINITION OF TERMS AND FEE AGREEMENT:** These terms and fee agreement apply to all applicant referrals employed by client within 36 months from date of referral by *AutoPersonnel*.

**Standard Longevity Guarantee:** *AutoPersonnel<sup>SM</sup>* agrees to provide replacement applicant for any applicant leaving within 90 days for 50 percent of standard fee. (Applies only to Option #1)

### Option #1 - Standard.

**Our fee is twelve percent (12%) of first year's projected gross compensation.**

NOTE: All fees under Option #1 are earned, due, and payable within 15 days of the date of employment.

### Option #2 – "Preferred Dealership Program

AutoPersonnel will offer the Client a Preferred Dealership Agreement wherein the twelve percent (12%) commission (based on the first year's projected compensation) will be paid in the following increments:

- 1) 50% of the total commission (6.0%) will be paid within 30 days of the date of employment.
- 2) 50% of the total commission (6.0%) will be paid within 60 days of the date of employment.

Option #2 is based on AutoPersonnel having a mutually beneficial relationship with the Client by meeting the Client's employment needs. Either party may cancel or request modifications to this Agreement, if not satisfied with the arrangement, with 60 day notice to the other party.
